What information we collect, use, and why

We collect or use the following information to provide services and goods, including delivery and third party referrals:

- Names and contact details
- Photographs or video recordings
- Service use history
- Dietary information (including allergies and health conditions)
- Records of meetings and decisions
- Payment details (including card or bank information for transfers and direct debits)
- Website user information (including user journeys and cookie tracking)
- Information relating to compliments or complaints

We collect or use the following information to **receive donations or funding and organise fundraising activities**:

- Names and contact details
- Payment or banking details
- Donation history

We collect or use the following personal information for **service updates or marketing purposes**:

- Names and contact details
- Marketing preferences
- Recorded images, such as photos or videos
- Records of consent, where appropriate

We collect or use the following personal information for **research or archiving purposes**:

- Names and contact details
- Addresses
- Records of consent, where appropriate

We collect or use the following personal information for **dealing with queries**, **complaints or claims**:

- Names and contact details
- Purchase or service history
- Witness statements and contact details
- Correspondence

We also collect or use the following information for **dealing with queries**, **complaints or claims, if the following information forms part of the request**:

- Racial or ethnic origin
- Sexual orientation information

We will never sell or rent your information to third parties for marketing purposes.

Lawful bases and data protection rights

Under UK data protection law, we must have a "lawful basis" for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the ICO's website.

How long we keep information

Our data will only be kept for as long as there is an administrative need to do so in order to enable our charity to carry out its business or support functions, or for as long as it is required to demonstrate compliance for audit purposes or to meet legislative requirements.

In general, records are kept for 6 years after the end of the accounting year to which they relate, but we do not keep personal records any longer than necessary and certain records may be required to be retained for longer.

We consider various criteria when determining the appropriate retention period for personal data including:

• The purposes for which we process your personal data and how long we need to keep the data to achieve these purposes.

- How long personal data is likely to remain accurate and up-to-date.
- For how long the personal data might be relevant to possible future legal claims
- Any applicable legal, accounting, reporting or regulatory requirements which specify how long certain records must be kept.
- Other factors including storage costs, historical value, industry standards, and archival needs, of which we are aware and will be compliant.
